The monthly transmittal of state monies for February 2021 contained a state monies amount that is still below our hold harmless floor of \$1,275,668 for Appleton City R-2 School District. The proration ratio has increased to 0.93916334 (93.9%) which results in a state monies total of S1, 198,061. This is a difference of \$77,607. Below the actual hold harmless floor. The position of DESE Finance at this time as stated in our latest webinar is that we will probably reach 0.95 (95%) at best by June. The allocation for ACR2 of ESSERII funding is \$351,622. The deadline for expenditure of funds is September 30, 2023.
